TULE SUBBASIN COORDINATION

Report on Ongoing Coordination Efforts Between Tule Subbasin GSAs

Executive Director McAteer provided a report. The draft coordination agreement is being reviewed by the legal counsels of the other Tule Subbasin GSAs. General Counsel Mauritson reported she is waiting on other attorneys to comment on the draft. The Subbasin Managers have met to discuss Harder's scope of work and deadlines.

GSP DRAFTING

Report on Progress of GSP Drafting

Executive Director McAteer provided a report on the progress of the GSP drafting. Attached hereto and incorporated by reference as Agenda Item #6a is a copy of the GSP drafting timeline.

Public comment was received from Don Castle.

Consider Potential Technical Analyses on Local Linkages to FKC Subsidence, Groundwater Transfer and Exchange Zones, and Other Data Gaps or Areas for Additional Technical Review; May Make a Recommendation

Executive Director McAteer provided a report on potential areas in need of technical review and prompted the committee to discuss.

Local Linkages to FKC Subsidence

Discussion amongst the committee ensued. Discussion ensued regarding the Stakeholder committee's recommendation on this issue and their discussion related to engaging other consultants.

Public comment was received from Don Castle.

Executive Director McAteer reported that the Tule Subbasin GSA managers had engaged Thomas Harder to provide the Subbasin MOU Group with a scope of work to investigate the local linkages to Friant-Kern Canal Subsidence and that a proposal for this Scope of Work would be distributed for consideration in Mid-November. Discussion amongst the committee ensued

regarding the approval of this scope of work and what other options may be available. Discussion ensued regarding the previous engagement of Thomas Harder.

Public comment received from Don Castle.

Committee member Geivet moved and Committee member Limas seconded to recommend that the Board approve the discussed scope of work that would have Thomas Harder undertake for the Tule Subbasin MOU Group an analysis on local linkages to subsidence, as described by Executive Director McAteer. The committee unanimously approved the motion.

Potential Groundwater Transfer and Exchange Zones

Discussion amongst the committee ensued on work related to transfers and whether or not this task was premature.

Public comment was received from Don Castle.

The committee did not make a recommendation on scope of work related to transfers.

Other Data Gaps or Areas for Additional Technical Review

Discussion amongst the committee ensued regarding the timing of the request for this scope of work and the request for additional experts other than Thomas Harder.

The committee did not make a recommendation on scope of work related to data gaps or other areas of technical review.

<u>Discuss Projects & Management Actions for Inclusion in Thomas Harder & Co Scenario Analysis Runs</u>

Executive Director McAteer provided a report. Attached hereto and incorporated by reference as Agenda Item #6c is a copy of Harder's model scenario project form.

Discussion amongst the committee ensued regarding timelines.

Review Policy Points F-J; May Make a Recommendation

Executive Director McAteer provided a summary of the Committees' previous recommendations on the various policy points.

Public comment from Don Castle.

Discussion amongst the committee ensued on previous policy points, specifically regarding transitional pumping.

Public comment was received from John Konda and Julie Inestroza regarding a joint meeting of the committees with the board, and the Stakeholder Committee's recommendation that the committees be invited to the upcoming Board Retreat

Discussion amongst the committee ensued regarding transitional pumping, and the Stakeholder committee's recommendation regarding historical use. Discussion ensued regarding transitional pumping for white area growers versus in-District growers.

Public comment received from Bill Samarin.

Discussion amongst the committee ensued regarding a two-tiered pricing mechanism for transitional pumping.

Public comment received from Don Castle and Bill Samarin, and Tom O'Sullivan.

Discussion ensued regarding staff constructing a policy paper on the proposal so everyone could be discussing the same proposal.

The discussion related to the remaining policy points were tabled.
